


Q1 Which of the following group(s) do you represent? (Please select all that apply)







Q4 Have you previously been a BOSSI member?



Q5 Are you currently (or previously been) involved with BOSSI committees or are (or previously been) an examiner?



Q6 Do you know how often BOSSI meets each year?



Q15 Do you feel that BOSSI communicates well with the profession?



Q16 How would you like BOSSI to communicate to you? (Please rank in priority order from 1-5, with 1 being the highest priority)







Q21 What age group are you in?


