- 5. When must the mine operator review and as necessary revise the mine survey plan as stated in the Work Health and Safety (Mines) Regulation 2014?
- 6. What is the requirement and statutory function of the nominated mine surveyor as stated in the Work Health and Safety (Mines) Regulation 2014?
- 7. What is the definition of "**barrier mining**" as described in the Work Health and Safety (Mines) Regulation 2014?

### Question 2 (10 Marks)

You are the Nominated Mine Surveyor for a modern UG coal mine and have been tasked with supervising contract surveyors working to install a transfer point, drive head and loop take-up for a new gateroad panel.

The area where the work will be carried out requires survey marks to be placed at heights greater than 3m as well as into the rib lines and floor.

Describe the planning process to ensure the surveys are carried out in a safe and efficient manner.

What legislative and mine requirements must be considered and addressed to cover the risks involved?

### Question 3 (10 Marks)

Describe the process to obtain approval and transfer of part of a mining lease granted under the Mining Act 1992 to another company.

List and provide detail for all consents that would be required to enable the transfer to proceed.

Provide plan detail including departmental restrictions that would be required to accompany the proposed transfer application.

### Question 4 (10 Marks)

You are the nominated surveyor for a small open cut coal mine that is looking to establish an emplacement area in an old mine void located within the mining lease area.

The proposal is to include buried services to provide power for decant water to be returned for reuse.

Detail the required application and the information to be recorded to comply with AS5488-2013(SUI)

#### Question 5 (10 Marks)

You are the Nominated Mining Surveyor for an open cut coal mine, where planning is underway to expand the Mine towards an area where a known but abandoned underground board and pillar coal mine operated.

The planned expansion is to initially operate in the same seam as the abandoned mine and then later, lower unmined seams.

Detail what archival research you would carry out and how you would verify the accuracy and extent of the workings depicted on various sources of information obtained.

Where a survey may be required on land not owned or under the control of the mining company detail who can enter the land, what can be surveyed and in which manner can entry be gained with reference to the Surveying and Spatial Information Act 2002. Question 6 (10 Marks)

You are the nominated surveyor of an underground gold mine.

Detail the survey requirements for Control Surveys performed underground to be compliant to ICSM SP1 version 1.7

As well as general requirements our answer should include:

- Observation requirements including tolerances
- Equipment calibration requirements
