- 4. In addition to the regular review, describe 3 occasions when an operator must immediately review the Health and Safety Management System, as defined in the Coal Mine Health and Safety Act 2002.

- 6. What are 2 occasions an operator must review the escape and rescue plan as described in the Coal Mine Health and Safety Regulation 2006?

Question 2A (5Marks)

You have been engaged as a consultant by the operator of a bord and pillar coal mine to prepare an Archival Research Report for some suspected underground coal and shale mines within the current mining lease, for consideration as part of a Risk Assessment for Inrush.

Detail what sources of information you would access and how you would verify it?

Question 2B (5Marks)

With reference to the Mine Health & Safety Regulation 2007, who is responsible to ensure that the mine plan is updated and how often must it be updated?

Who must certify a mine plan at a mine with greater than 20 employees and what is that person certifying?

Question 3 (10 Marks)

You are the Nominated Mining Surveyor for a longwall coal mine.

You are planning to carry out a primary control traverse of a three (3) kilometre gate road from the Mains to the production face, however the installation road has not yet been formed up.

The mine is known to be susceptible from lateral movement from the adjacent longwall goaf.

With reference to ICSM SP1 (version 1.7), detail what considerations you would have in planning and carrying out the survey to achieve Class D or better?

Question 4 (10 Marks)

Your mine has a lease for a down cast shaft that is at a remote location.

The lease does include an access road.

Detail your legal righto access this shaft and any survey requirements that may be required under the Mining Act and Regulation?

Question 5 (10 Marks)

You are the Nominated Mine Surveyor at an open cut coal mine.

Describe the process and applications involved to allow company to mine the barrier between the open cut and some disused underground workings previously operated by your company at the site?

Question 6 (10 Marks)

You are the Nominated Mine Surveyor at a new underground metalliferous mine.

The surveyors under your control include workers directly employed by the company and some workers engaged through a contracting company.

You have noticed increasing tension and animosity among the surveyors and are concerned that a degree of work place harassment may be taking place.

Detail what actions you would take to resolve this situation ensuring compliance with the provisions of the Work Health and Safety Act and Regulation?
