### Question 2 (10 Marks)

You are sole trader specialising in laser scanning for engineering works and have been engaged by a large multi-disciplined survey company to assist with a project to provide a highly detailed point cloud model for the design of an acoustic wall at a coal handling and preparation plant for a mining company.

The plant will be operational on the day the survey is to be undertaken.

Detail the steps and processes that would enable you to go to site and complete the work.

#### Question 3 (10 Marks)

You have been employed as the Registered Mine Surveyor for a brand new open cut coal mine. The mining lease covers an area which has existing underground workings in one particular seam from the 1930's which are going to be mined through using open cut truck and shovel methods. You are required to carry out archival research to locate the position of all existing workings.

Detail the method and steps required to confirm the location of the existing underground workings and any other workings that surround the proposed mining lease. (5 marks)

An abandoned underground coal mine has been closed for 10 years and due to an increase in the price of coal your company has decided to re-open the mine and appoint you as the Registered Mine Surveyor.

In regards to the Work Health and Safety (Mines and Petroleum Sites) Regulation 2014, outline the duties of a Registered Mine Surveyor. Your answer should include all survey and mine plans required and any other relevant information as outlined in 'Part 5' of the Work Health and Safety (Mines and Petroleum Sites) Regulation 2014. (5 marks)

### Question 4 (10 Marks)

## Q4a (2.5 marks)

A mineral sand operation is establishing survey control for a long narrow resource within their mining lease. Detail how access to several high class Permanent Survey Marks (SCIMS marks), which exist adjacent to the site on private property, may be gained under the Surveying and Spatial Information Act 2002.

### Q4b (7.5 marks)

For the same operation outlined above, detail with reference to ICSM (2007) SP1 (version 1.7), how you (as the Nominated Mining Surveyor) would plan and carry out the survey to achieve Class "D" as a minimum.

### Question 5 (10 Marks)

#### Part A

You are the Nominated Mining Surveyor at an Underground Coal Mine, approaching retirement. Discuss the process and obligations around charting cessation of duties.

#### Part B

You are the newly appointed Nominated Mining Surveyor at an Underground Coal Mine.

You have been provided with a Robotic Total Station that has just been serviced.

Discuss what you might do in order to use this instrument for surveys to complete your Mine Survey Plan, mentioning how this process has addressed common errors and corrections associated with electronic distance measuring equipment.

### Question 6 (10 Marks)

You are a contract registered surveyor for a small open cut mining operation.

The operation is struggling for water and is looking for any sources available.

They have informed you of some old UG workings that exist outside of their current Mining Lease but on land owned by the mining company, which may be flooded.

Explain some of the major points to be investigated in relation to this source of water.

What would be required by the company to be able to explore and extract water from these workings?
