The *Surveying and Spatial Information Regulation 2017* outlines that CPI will be applied annually to the Schedule 7 fees and deposits. For 2020/2021 a CPI of 2.2% has been applied. A copy of the new fees and deposits schedule is available on the BOSSI <u>website</u>

### **Board Determinations**

BOSSI has reviewed and updated all of its current determinations

<u>BOSSI Determination - Board Examinations</u> – minor revisions and clarifications for all projects, introduction of 'fit and proper person' requirements for candidate and examination applications. The Determination now incorporates information from *BOSSI Guidelines for Land Surveying Assessments* which has been retired. This means that all Board examination related requirements and information are contained in the one comprehensive document. The requirements outlined in the Determination will apply from the October 2020 Board examinations, so candidates and their supervising surveyors

must review the document to ensure that your project complies and that the correct deliverables are prepared. If your project does not comply you will need to apply to BOSSI for a variation approval.

 <u>BOSSI Determination - Continuing Professional Development</u> – overall CPD point requirements remain unchanged. A number of amendments have been made to the CPD points available for career and professional volunteering related activities. From 1 July 2020;

Being a member of a professional association no longer attracts a CPD point

- Supervision of BOSSI candidates outside of structured workshops or programs does not attract CPD points
- Attendance at career expo days does not attract CPD points
- Total allowable points for all career and professional volunteering related activities is now limited to a total of 5 points
- BOSSI Determination Recognised Qualifications minor updates and amendments
- <u>BOSSI Determination Supervision</u> minor updates and amendments. The Determination
  now incorporates information from BOSSI Registration Examinations: Guidelines for
  Surveyors who are supervising Candidates at the Land Surveying Assessments which has
  been retired. This means that all supervision related requirements and information are
  contained in the one comprehensive document.

## **Registration Renewal Process**

BOSSI migrated to the Government Licencing System (GLS) in March 2020. In early July the system will send you a renewal notification via email. It is essential that your email address with BOSSI is current and correct. If you haven't already please log into the system to ensure that we have the correct details.

# Reminder - Surveyor ID (licence) numbers are now prefixed with a registration type, for example

- ID number 1234 for a Surveyors Assistant is now SA001234
- ID number 4321 for a Candidate Surveyor is now CA004321
- ID number 5678 for a Registered Surveyor is now SU005678

Reminder - CPD Summary reports from a ratified organisation or a letter from the Board granting a conditional compliance or exemption from CPD requirements will be required to be uploaded (PDF) when making payment for a renewal of Registration. Renewal cannot proceed without the required document being submitted.
