# **Registration Renewals and CPD Compliance**

Thank you to those surveyors that have already undertaken their registration renewal and supplied evidence of their compliance with the Boards CPD Determination.

As of 30 July 2021, BOSSI has processed and approved the renewal of over 600 Registered surveyors. The renewal period is still open until 31 August 2021 for those surveyors yet to make payment and upload evidence of the CPD compliance.

For surveyors that are short CPD points for the 2020 / 2021 CPD Year, a conditional compliance of CPD application is required to be sent to BOSSI by 31 July 2021 to avoid being removed from the Register of Surveyors for non-compliance of CPD.

### **BOSSI Examinations**

The COVID-19 situation is changing regularly, and while BOSSI intends to hold examinations for land and mining Candidates in October 2021, there is a risk

that if the situation remains escalated or expanded beyond current lockdowns and restrictions, that the restrictions may prohibit BOSSI from conducting the exams.

BOSSI will review the situation and advice from Government over the next 4 weeks and will provide an update to surveyors as to the Board's intention to proceed or cancel examinations in October 2021.
