CPD Update

- A reminder to all Registered Surveyors that there is less than 4 weeks left of the 2021/2022 CPD Year to get
 any remaining required CPD points. 15 points in total including 5 specialty points for each specialty area
 (cadastral or mining) are required
- Start reviewing your CPD points now, as the EOFY is fast approaching do not leave it until it is too late!
- If you have undertaken events that are not assessed for BOSSI points, but you believe would be relevant, get these assessed by your chosen RO as soon as possible as this process can take 2 3 weeks.
- Do not forget you need a minimum of five points from DM1 (professional volunteering and preparation of presentations do not count)
- If you have achieved your 15 points already, get your request for a CPD Summary Report/s in as soon as possible, don't wait!

Important Dates to remember:

- 30 June 2022 All CPD Points must have been obtained by this date.
- 31 July 2022 All applications for Conditional Compliance or Exemption must be received. Any applications received after this date will be automatically rejected. Please refer to the BOSSI Determination Continuing Professional Development for relevant forms available on the BOSSI website regarding these applications.
- 31 August 2022 All registration renewals must be submitted, and payment made. Failure to do so will result in removal from the register.

2022 BOSSI Fee Update
